Note from the desk of **Smt. Sudha Wagh** Founder & Hon. Secretary

Snehajyot has completed two years of its establishment, and I am delighted and proud to say that in these two years, we have been able to create a fruit of our efforts as activists. This fruit is not just significant for the cause of differentlyabled rehabilitation but also reflects our dedication to contribute wholeheartedly.

When we look at differently-abled individuals, we often see someone who needs support, and it's natural to sometimes do something for someone out of sympathy. However, the direction and intent behind our giving can have a significant impact on the recipient's psyche. Therefore, while our cooperative efforts may bring assistance, it's crucial that we approach it with empathy rather than pity. This is what makes our cooperation truly meaningful. We practice this philosophy in Snehajyot. And to inculcate this mindset among our Sevavratis, we organize their group meetings as well as training sessions from time to time.

Each differently-abled person has unique challenges, mentally, physically, and socially. Understanding these differences and tailoring our efforts accordingly is essential. While many may not notice the obstacles differently-abled individuals face, we are aware. Setting up a new venture called Divyang Zomato Delivery Services by partnering with Neo Motion and Zomato, Partnering with Flexmo to provide modern & disabled friendly designed crutches and walkers to the disabled, distribution of the Snehajyot Dhairyashali Vyaktimatva Puraskar to a person with a disability who overcomes adversity and shows strength beyond his own abilities, UDID Card and Sanjay Gandhi Niradhar Pension Yojana movement, supporting Mumbai Wheelchair Cricket Association, Felicitating the disabled individual who has made remarkable progress in Para-Sports with Snehajyot Shaktishali Vyaktimatva Puraskar...all these activities are our sincere efforts to implement what we understand.

We are aware that the path to complete differently-abled rehabilitation is long and challenging but achievable. However, the required place is not yet available to us.

In the past two years, we have initiated several programs, most of which are currently being run from a small place in Dahisar East. The government and philanthropic efforts are in progress. I express hope and confidence that in the coming year, we will have the necessary place and resources for our various projects so that we can expand our reach to many differently-abled individuals not only across Mumbai but also Maharashtra.

OUR STORY

Snehajyot Divyang Seva Pratishthan is formed by Shri Aroon Walavalkar, Smt. Sudha Wagh, Shri Milind Tendulkar & Smt. Aparna Kaikini with the guidance of Shri Vishnu (Dada) Patwardhan who has devoted his life for the social, cultural & educational development of the society.



The founder **Shri Aroon Walavalkar** was in service with Larsen & Toubro Ltd for 36 years and retired in the year 2002 as In-charge of Larsen & Toubro Service Training Centre, Bangalore. After his retirement, he was closely associated with the rehabilitation process of physically challenged community which was initiated by Mrs. Sudha Wagh. In the year 2021, he thought of forming a trust on the 1st Death anniversary of his beloved wife Late (Smt) Snehalata Walavalkar.

Smt. Sudha Wagh has been working restlessly on the rehabilitation of physically challenged people for more than 35 years. "If you are working on something that you really care about, you don't have to be pushed, the vision pulls you". This quote of Steve Jobs aptly sums up the personality of our dedicated Sudhatai Wagh.





In the year 1989, **Shri Vishnu (Dada) Patwardhan**, founder of the well-known, Asmita Trust rightly identified Smt. Sudha Wagh as Centre Head of M. H. Chogale centre rehabitation centre for handicapped, Borivali. It was a great challenge for her to work as there was no proper road, water, electricity and transport facility also. But she accepted the challenge and started functioning in a planned manner. Her sincerity, hard work and concern for Divyang people has brought this M.H.Chogale centre to a new height and today it is a pride of Asmita for its great social contribution.

Now, Smt. Sudha Wagh has joined hands with Shri Aroon Walavalkar along with a number of volunteers with a view to establish one more shelter for Divyang people and bring more & more Divyang under an umbrella of Snehajyot Divyang Seva Pratishthan by keeping broad objectives in mind. She has been honoured a number of times for her extraordinary work in the social field by many organisations. Some of them are Sanjeevani World School, the Inner wheel club of Borivali, Samata Mahila Mandal. She was awarded with the 'Seva Ratna Samman' by Bhartiya Shikshan Mandal (Sanskar Bharati) Kanpur & 'The most inspiring lady of the year 2022' by Atharva Foundation.



Shri Milind Tendulkar is another pillar & founder of Snehajyot. He was in Bank's service for 34 years and retired as Branch Manager, Bank of Baroda, Amboli branch in January 2015. He along with his wife, Mrs Namita Tendulkar has decided to devote their post-retirement life to making their contribution to rehabilitating the physically challenged people & provided significant part of their retirement fund to the cause.

Smt. Aparna Kaikini, another founder of the NGO & retired principal of the Primary Section of Shailendra Education Society, Dahisar has always been a backbone & mentor of Ms. Sudha Wagh in her journey. Snehajyot is heading towards its aim under the strong presidency of



Mission

A mission of Snehajyot Divyang Seva Pratishthan is to help physically challenged people to know their strengths by proper counselling, give them medical assistance & make them aware of opportunities available to them to earn their own livelihood.

Activities 2022-23

1. UDID Card movement

Government of India has now made UDID card mandatory as an identity card for persons with disabilities. But the process of getting it is very complicated and very troublesome for a physically challenged person. Keeping all this in mind, our volunteers Namita Tendulkar and Dr. Manjusha Shewale took a vow to get UDID cards to as many people with disabilities as possible. Both of them carried out all the procedures like taking complete information and documents of the disabled persons, taking them to the government hospital on the scheduled date, being with them till all their check-ups are over. We are proud to say that we have assisted nearly 86 persons with disabilities in the process of getting UDID cards in the last six months.









2. Sanjay Gandhi Niradhar Pension Yojana Movement

Similar to the UDID card, another very useful but complicated government scheme for the disabled is the Sanjay Gandhi Niradhar Pension Yojana. But Sevavrati Namita Tendulkar with the help of secretary Sudha Wagh and Sevavrati Vaishali Argade & other sevavratis completed all the paperwork of this scheme for as many as 25 disabled candidates who have already started receiving the pension in the current financial year.

While implementing this plan, our Sevavratis took an innovative initiative. A one day camp was organized directly in the Tehasildar office after meeting the concerned government officials and all the documentation was completed on the same day. Similarly, NGO's Vice President, Nayan Walawalkar, who is also an officer of Punjab National Bank, opened savings accounts for these 25 disabled persons within a day in Snehajyot's office itself.

It is our resolve to take this pension scheme benefit to maximum number of disabled persons with the help of government officials







3. Surveys & Findings

As per Statistics of Census 2001, about 21 million people are physically challenged in India which comes to 2.1 per cent of our total population. The disability rate is 2130 per lakh population. Home studies and various reports show that 12.6 million are male and 9.3 million are female. Among the five types of disabilities on which data has been collected visual disability is 48.5 % emerges as the top category. Others in sequence are in movement 27.9 %, mental 10.3 %, in speech 7.5 % and in hearing 5.8 %.

We conducted various surveys into the slum areas. It is observed that family members of the disabled are reluctant to



send their children to NGOs as they firmly believe that their disable child can not do anything. To convince the parents to send their children to the Centre is a huge challenge.

4. Counselling

We arranged various counselling sessions for the disabled as well as their parents also. Most of them are depressed and to bring them out of depression, we need to give them positive strokes from outside, as well as from their parents. Only then they get motivated to do something. This is an ongoing process.



5. Medical Support & Necessary Treatment

Various medical checkups were done and Doctor's expert opinion were obtained on whether the disabilities of our students can be reduced to some extent. For example, it is our experience that for many handicapped people, a small surgery or regular physiotherapy has helped them to walk with crutches, rather than crawl with hands.





6. Providing life support & medical equipments.

We provided many disabled people the required life support equipment like crutches, wheelchair, tricycle, limb etc. who can't afford to buy them.







6a. Flexmo Crutches & Walkers Distribution

Snehajyot provided Disabled Friendly Elbow Crutches, Under Arm Crutches and Walkers designed by 'Flexmo' to as many as 52 differently abled persons. These special devices, designed keeping in mind the difficulties faced by disabled people in walking, are becoming very useful for many disabled people today. Voice Of SAP, an international organization working for persons with disabilities, was impressed by Snehajyot's work and funded this project. Snehajyot is working on how to make these devices more effective for people with different types of disabilities by discussing with those who have been given these devices.









7. Support for Self Employment

7a. Zomato Project in association with NeoMotion

By tying up with NeoMotion, a company that manufactures electric scooter-cum-wheel chair, an innovation of alumni IIT Madras, Snehajyot supported three disabled persons namely Praveen Shinde, Nizamuddin Pathan and Harishankar Sharma on an experimental basis for the business of Zomato delivery services. We are proud to say that today Snehajyot has made these three individuals financially self-reliant in their lives by addressing & solving all the problems they face while doing this venture.









CEO of Neomotion, Siddharth Daga has helped around 25 people in Maharashtra to start such business with the support of HT Parekh Foundation. All three Snehajyot candidates are in the top 10 in terms of income in the last six months in a recent survey. And our Praveen Shinde is at number one with an average monthly income of Rs. 20,000/-. After the success of this initiative, Snehajyot intends to implement this project on a larger scale with many more disabled people who want to get into delivery service business.

7b. Distribution of E-Tricycle for business support

Shrikant Joshi, Secretary of Vatsalya Trust, is our old well-wisher. In collaboration with the Vatsalya Trust, electrical tricycles were distributed to some of our disabled colleagues to support their livelihood on the occasion of World Disabled Day.





8. Skill Training & Development Centre

Skill Development Training Centre is one of the specialties of Snehajyot! So far, many disabled people have mastered sewing and handicrafts and are now doing their own business. Many different arts such as making purses, shirt covers, saree covers and embellished paper flowers, bouquets are taught in our skill development centre. The physical ability of each person who comes to this centre is properly studied and accordingly the method of teaching is decided.







From the inception of the institution till today, the trustees, Supriya Phadke and Madhavi Gavankar, have flourished the handicraft department very beautifully. Sheela Pagare, who was trained in our own sewing department and mastered the art of sewing, is now teaching this art to other differently abled persons in our centre as a teacher.

Through stalls held at various places, exhibitions, and orders received for various events, the products produced in this training centre are sold and through this, our disabled associates are provided with an opportunity to earn money.
















9. YOGA practice for empowerment

Dr. Manjusha Shewale, trustee of the NGO, has been a yoga practitioner and trainer for many years. Everyone knows the importance of yoga for a healthy life, but she inculcated the idea that yoga can be a very useful medium for the mental and physical empowerment of persons with disabilities. And through online batches, yoga practice has been established in the lives of many disabled persons. With her inspiration every year on 21st June on the occasion of World Yoga Day, Snehajyot and all colleagues organize a small yoga practice camp. Sheela Shah of Ambika Yogashram, State Bank officer & yoga practitioner Desh Raj Choudhary, Yoga teachers Nital Mhatre & Anuradha Tendulkar were present as yoga instructors this year.













10. Diwali Celebration with our Divyang Friends

Many of our disabled colleagues are in such a financial situation that they have to struggle even for daily living. Every Diwali, our Sevavratis go to their homes and give Diwali Faral & sweets as a gift to our disabled friends. This exchange of happiness is very special for us on Diwali.







11. Mumbai Sports Festival for Disabled

There is no such thing as outdoor sports can only be played by physically fit people. Even a disabled person can enjoy outdoor sports with equal vigour and joy and this year, India has won more medals in Paralympics than in normal Olympics. In line with this, Snehajyot organizes the Mumbai level Divyang Sports Festival every year on the occasion of World Disability Day. This year also around 150 persons with disabilities from all over Mumbai participated in this sports festival at Poisar Gymkhana in Kandivali & enjoyed various games to heart's content for the entire day. Honorable M.P. Mr. Gopal Shetty provided valuable support for this program. Famous actors Samir Chowgule, Avinash Narkar, Aishwarya Narkar and Shreya Bugade made a special appearance for the sports festival.













12. Snehajyot Shaktishali Vyaktimatva Puraskar 2023

Snehajyot organizes the Divyang Sports Festival every year on the occasion of World Disabled Day. On the occasion, some disabled athletes who have performed outstandingly in para sports are felicitated with Snehajyot Shaktishalii Vyaktimatva Puraskar' every year. This year, National Award winning disabled athlete, Devdatt Mane and National Para Basketball player Prerana Dhone were honoured with cash prizes and a momento.





13. 26th January - Shatabdi Hospital Visit

Every year on January 26, special honors are given to persons and organizations doing social work at the hands of differently-abled students of Snehajyot. This year, the staff and superintendent, Shatabdi Hospital in Kandivali, which is committed to patient care, were honored by presenting paper flowers made in Snehajyot.









14. Snehajyot Kalamanch

During disabiled rehabilitation process, we realized that many disabled persons are gifted with various arts. 'Snehjyot Kalamanch' has been created by bringing together the differently-abled persons who have very beautiful singing and playing skills. Currently in its rudimentary form, this kalamanch presents beautiful songs at the various events like Family functions, Society events, Corporate events. In the future, Snehajyot dreams of creating an innovative art platform with high entertainment and production value by bringing together the best artists from the community.







15. Snehajyot Dhairyashali Vyaktimatva Puraskar 2023

Even with a physical handicap, some people navigate their lives with an energy and determination that would put even the physically fit person to shame. Snehajyot has started the 'Snehajyot Dhairyashali Vyaktimatva Puraskar' from this year with an aim to keep the inspiring role model of such individuals in front of the society. Arun Ghule, who, despite losing his legs in an unfortunate accident, has made a name for himself in the business of extracting coconuts from coconut trees using his own skills. Arun not only supports his own family but also stands behind the team he set up to work under his guidance. The award was in the form of a cash prize and a momento.



16. Krisha – A wonder girl

Krisha is a very intelligent girl but disabled by birth. When Krisha was brought to the institution, she could not control her movemets. Our trustee Anagha Bhave took responsibility of Krisha's physiotherapy and gradually Krisha's physical condition improved. Today Krisha sits on her own. She has control over her body movements. Our Sevavratis, Padmaja Vaidya and Smruti Narvekar visit her home every few days and do a grooming session with her. The progress made in Krisha's physical & mental status is very satisfactory.







17. Support for Educational Expenses

Proper and good education is very important for all of us. It is the process of achieving knowledge, values, skills, beliefs and moral habits. We assure that not only disabled people are educated but their next generation also gets good education. We reimburse the school fees of their children. So we are creating a database of their children and ensuring that no child is deprived of education due to financial issues. Thus every child's right to education is protected. We believe in improving their standard of living and upliftment of the poor in a true sense.



18. Follow Up Visits

Any kind of support provided by Snehajyot to a disabled colleague is really useful to him or not, if he or she needs any improvement, if he or she needs any more support system, all these things are checked by a follow up team. After supporting an individual, our follow up team of Supriya Phadke, Umesh Zarapkar, Jyoti Kokil, Deepak Paradkar, Angha Bhave visits the individual at regular intervals and monitors all the above mentioned aspects. Accordingly, it helps us to better shape the disability rehabilitation process we are doing.

Significant Accounting Policies

- The society follows "Accrual Basis" method of accounting. The incomes as well i) as expenses are accounted on accrual basis.
- ii) Fixed assets are stated at cost less depreciation. The cost comprises of purchase price and any attributable cost of bringing the assets to working condition for its intended use. The subsidy received for solar project has been reduced from the cost of the project.
- iii) Depreciation has been provided on written down value basis generally at the rates specified in Income Tax Act. 1961 for Furniture @ 10%, Vehicles @15%. On other assets Equipment's etc., depreciation is charged @15% pa, computers @40%, on Buildings @ 5% p.a.
- iv) Investments are stated at cost.
- V) Closing stock is valued at lower of cost or net realizable value.

Il Notes to Accounts

- i) The Cash on hand Rs. 11,473/- as on 31st March'2023, was physically verified by the Management.
- ii) The Fixed Assets Furniture, Fixtures, Computers & other Equipment's stated in the Balance Sheet were in use and verified by the management.
- iii) Investment of Rs. 26,50,000 in fixed deposit for Donations of Rs. 26,50,000 received towards corpus fund during the current year is made within the end of the current financial year with Schedule Bank.
- iv) Previous year's figures have been regrouped wherever necessary.


