Note from the desk of **Smt. Sudha Wagh** Founder & Hon. Secretary

१९८९ साली जेव्हा गुरुतुल्य श्री दादा पटवर्धन यांच्या मार्गदर्शनाखाली मी दिव्यांग पुनर्वसन कार्याची सुरुवात केली, तेव्हा मनात एकच इच्छा होती की आपल्या हातून जे काही घडेल त्या प्रत्येक कृती मधून दिव्यांग व्यक्तींचे आयुष्य अधिक सुकर व्हावे. गेल्या ४० वर्षांमध्ये भौतिक परिस्थिती बदलली असली तरी दिव्यांग व्यक्तींच्या अवतीभवतीची मानसिक, सामाजिक, आर्थिक, कौटुंबिक परिमाणे अजूनही फारशी बदललेली नाहीत आणि म्हणूनच आजही किंबहुना काही गोष्टींच्या बाबतीत अधिक कठीण आव्हाने दिव्यांग पुनर्वसन कार्यात अस्तित्वात आहेत.

माझे काही समविचारी सहकारी एकत्र येऊन ३ वर्षांपूर्वी आम्ही 'स्नेहज्योत दिव्यांग सेवा प्रतिष्ठान' संस्थेची स्थापना केली. त्याचा उद्देश याच आव्हानांना एकत्रितपणे सामूहिक बळ देऊन कशा पद्धतीने सामोरे जाता येईल, हाच होता.

दिव्यांग व्यक्तीच्या अनेक गोष्टींसाठी तो इतर आजूबाजूच्या व्यक्तींवर अवलंबून असतो. त्याच्या या गरजा पूर्ण करण्यासाठी अवतीभवती जर अनुकूल परिस्थिती नसेल तर त्याचे जगणे जास्त कठीण होते आणि अशा वेळेला अनेक दिव्यांग व्यक्ती मानसिक आजाराने त्रस्त झालेले दिसतात. अशा वेळेला फक्त त्यांच्या कौशल्य विकासावर भर न देता त्यांच्या मानसिकते वरती सुद्धा काम करणे गरजेचे आहे, हे प्रकर्षाने लक्षात आले. त्यातूनच दिव्यांग व्यक्ती व त्यांच्या पालकांचे समुपदेशन प्रक्रिया आम्ही सुरू केली.

दिव्यांग व्यक्तींनी स्वतः स्वतःच्या हिमती वरती अर्थार्जन करणे हा त्यांच्यासाठी त्यांच्या आत्मविश्वासाच्या प्रवासातला एक महत्त्वाचा टप्पा ठरतो, हे ध्यानात घेऊन आम्ही दिव्यांग व्यक्तींच्या स्वयंरोजगार निर्मितीसाठी ठोस पावले उचलली. निओमोशन, झोमॅटो, ॲमेझॉन या कंपन्यांसोबत हात मिळवणी करून डिलिव्हरी सर्विसेस मध्ये आज आमचे अनेक दिव्यांग सहकारी स्वावलंबनाच्या वाटेवरती प्रवास करते झाले आहेत,

हा अहवाल वाचल्यानंतर आम्ही कोणते कोणते उपक्रम कशा पद्धतीने राबवले आहेत, याची कल्पना येईलच. पण महत्त्वाचे इथे नमूद करायचे म्हणजे हे सर्व कार्य आम्ही करू शकलो कारण दिव्यांग पुनर्वसन कार्याचे व्रत निरपेक्ष भावाने करणारे अनेक सेवाव्रती इथे एकत्र आहेत.

स्नेहज्योत ला कोणतेही सरकारी अनुदान नाही पण तरीसुद्धा संस्थेच्या संपर्कात आलेल्या दिव्यांग व्यक्तींच्या गरजा पूर्ण करण्यासाठी आम्हाला कधी वाट बघावी लागली नाही कारण आमचे मोठ्या मनाचे दाते!

दिव्यांगांचे आयुष्य स्वावलंबनाकडे नेण्यासाठी जी प्रामाणिक तळमळ लागते, तीच आम्हा सर्व कार्यकर्त्यांची ताकद आहे. आणि याच प्रखर इच्छेच्या ताकदीवरती आम्ही हे दिव्यांग पुनर्वसनाचे कार्य अधिक प्रभावीपणे आणि दिव्यांग व्यक्तींच्या एकंदरीत आयुष्याला अनुकूल अशा पद्धतीने करत राहू, असा मला विश्वास वाटतो.

इंग्रजी अनुवाद

In 1989, under the guiding hand of my mentor, Shri Dada Patwardhan, I embarked on a journey of rehabilitating persons with disabilities. My heart held one simple wish: to bring ease and dignity to their lives through every step we took together. Though material conditions have evolved over the past 40 years, the mental, social, economic, and familial challenges surrounding persons with disabilities remain largely unchanged. In fact, in some ways, the obstacles we face today in their rehabilitation have only grown more complex.

Three years ago, a few like-minded colleagues and I founded the 'Snehajyot Divyang Seva Pratishthan.' Our purpose was clear: to come together, combine our strength, and face these challenges head-on, ensuring that no one had to struggle alone.

People with disabilities often depend on those around them for their basic needs, and when their environment doesn't support them, their struggles deepen. Many end up battling mental health challenges, trapped by circumstances beyond their control. It became painfully clear to us that skill development alone would not be enough. We needed to nurture their mental and emotional resilience as well. That's why we started counseling programs for both the disabled and their families, recognizing that their well-being extends beyond the physical.

A pivotal moment in a disabled person's life is when they can earn their own livelihood. It's a transformative step in their journey towards self-confidence. Understanding this, we took concrete steps to create self-employment opportunities. Through partnerships with organizations like NeoMotion, Zomato, and Amazon, many of our disabled colleagues are now walking the path of independence, serving in delivery services with pride and purpose.

As you read this report, you will see the various initiatives we have implemented. But what I want to highlight is this: none of this would have been possible without the selfless dedication of many volunteers who have devoted themselves to the cause of rehabilitation for persons with disabilities, not for recognition but for the pure joy of service.

Despite receiving no government grants, we have never had to wait to fulfill the needs of the disabled individuals we serve. This is only because of the generosity of our donors, whose hearts are as large as their contributions.

The sincere passion needed to guide persons with disabilities towards self-reliance is the very strength that drives all of us in this mission. It is with this unwavering commitment that I am confident we will continue to make this rehabilitation work even more impactful, creating a world that is more inclusive and supportive of their dreams and aspirations.

When people who share a common vision and a deep sense of social responsibility connect, they generate extraordinary and meaningful outcomes.



The founder **Shri Aroon Walavalkar** was in service with Larsen & Toubro Ltd for 36 years and retired in the year 2002 as In-charge of Larsen & Toubro Service Training Centre, Bangalore. After his retirement, he was closely associated with the rehabilitation process of physically challenged community which was initiated by Mrs. Sudha Wagh. In the year 2021, he thought of forming a trust on the 1st Death anniversary of his beloved wife Late (Smt) Snehalata Walavalkar.

In the year 1989, **Shri Vishnu (Dada) Patwardhan**, founder of the well-known, Asmita Trust rightly identified Smt. Sudha Wagh as Centre Head of M. H. Chogale centre rehabitation centre for handicapped, Borivali. It was a great challenge for her to work as there was no proper road, water, electricity and transport facility also. But she accepted the challenge and started functioning in a planned manner. Her sincerity, hard work and concern for Divyang people has brought this M.H.Chogale centre to a new height and today it is a pride of Asmita for its great social contribution.





Smt. Sudha Wagh has been working restlessly on the rehabilitation of physically challenged people for more than 35 years. "If you are working on something that you really care about, you don't have to be pushed, the vision pulls you". This quote of Steve Jobs aptly sums up the personality of our dedicated Sudhatai Wagh.

Now, Smt. Sudha Wagh has joint hands with Shri Aroon Walavalkar along with a number of volunteers with a view to establish one more shelter for Divyang people and bring more & more Divyang under an umbrella of Snehajyot Divyang Seva Pratishthan by keeping broad objectives in mind. She has been honoured a number of times for her extraordinary work in the social field by many organisations. Some of them are Sanjeevani World School, the Inner wheel club of Borivali, Samata Mahila Mandal. She was awarded with the 'Seva Ratna Samman' by Bhartiya Shikshan Mandal (Sanskar Bharati) Kanpur & 'The most inspiring lady of the year 2022' by Atharva Foundation.



Mr. Milind Tendulkar is another pillar & founder of Snehajyot. He was in Bank's service for 34 years and retired as Branch Manager, Bank of Baroda, Amboli branch in January 2015. He along with his wife, Mrs Namita Tendulkar has decided to devote their post-retirement life to making their contribution to rehabilitating the physically challenged people & provided significant part of their retirement fund to the cause.

Ms Aparna Kaikini, another founder of the NGO & retired principal of the Primary Section of Shailendra Education Society, Dahisar has always been a backbone & mentor of Ms. Sudha Wagh in her journey. Snehajyot is heading towards its aim under the strong presidency of Kaikini bai.

Activities 2023-24

Independence Initiative through Self Employment Support



For a physically disabled person, becoming independent and self-empowered is crucial for living with dignity and confidence. It allows them to overcome challenges and build a meaningful life.

At our NGO, we believe that every person, regardless of physical disability, has the right to create their own path and contribute meaningfully to society, unlocking their full potential.



Sandeep and Gayatri Jangam are two of our dear friends who, despite their challenges, have enriched their lives together through sheer determination. Whether it was overcoming obstacles in the development process of their home to finally taking possession of it, or rebuilding a new stall for their livelihood after losing the previous one—Snehajyot has always stood by this fighter couple. No matter the difficulties they face, they never lose hope and continue to work hard to sustain themselves

In their journey, our well-wisher, Mr. Sanjeev Dandekar, has extended invaluable support. Their stall in Mira-Bhayandar lacked two essential items for their business: a juice machine and a commercial fridge. Sanjeev Dada stepped in and provided these necessities. On May 1, 2024, Maharashtra Day, this Marathi couple received crucial support from a fellow Marathi individual, truly celebrating the spirit of the day.

Elevating Employment Opportunities



Securing a stable job is a challenge even for physically abled individuals, so one can only imagine how significant this issue is for those with physical disabilities. Without the right education and skills, finding a job is already difficult. To explore ways to provide skills aligned with industry requirements to the 'job-seeking' differently-abled individuals within our network, a seminar was organized at Snehajyot by Mr. Shrikant Joshi of Vatsalya Trust. Nearly 50 differently-abled individuals registered and participated in the seminar, receiving answers to all their questions from Mr. Shrikant. Under this initiative, a program is being planned through the joint efforts of Snehajyot and Vatsalya Trust to provide employment opportunities to as many differently-abled individuals as possible.







Sanjay Gandhi Niradhar Yojana: 2nd Year of Successful Impact

Last year marked a significant milestone with 25 differently-abled individuals receiving benefits under the Sanjay Gandhi Niradhar Pension Scheme with the efforts of our sevavrati, Mrs. Namitatai Tendulkar.

Recognizing the dedication with which our Namita Tai spearheaded this effort, even government officials extended their cooperation. This led to the organization of a pension scheme camp at our institution.







The Tahsildar and Talathi officers personally attended the event, and the process of enrolling around 52 differently-abled individuals in the pension scheme was initiated. Residence and income certificates were promptly issued, and soon, the benefits of this scheme were credited to the accounts of our 52 differently-abled families.

Government schemes are often complicated, but thanks to the persistent efforts of Namita Tai and the support of our dedicated volunteers, we were able to bring "Government to your doorstep."

Zomato Delivery Employment Program



A year ago, Snehajyot initiated an innovative project, enabling persons with disabilities to work in the Zomato delivery business. This initiative, supported by HT Parikh Foundation and using specially designed electric wheelchairs by Chennai-based NeoMotion Company, has empowered the first batch of trainees Pravin Shinde, Nizamuddin, and Harishankar Sharma to now earn up to ₹25,000 per month.

Inspired by their success, Snehajyot's next batch of 16 differently-abled individuals is now ready to take flight and soar in this self-employment venture.







Skill Training & Development Centre





Snehajyot, our Skill Development Training Centre continues to stand out as a cornerstone of our mission. This year, we've proudly seen numerous individuals with disabilities master the arts of sewing and various handicrafts, leading them to successfully launch their own businesses. Our centre offers training in a range of purses, shirt covers, saree covers, and decorative paper flowers and bouquets, tailored to each person's unique abilities.

Since our inception, trustees Supriya Phadke and Madhavi Gavankar have expertly nurtured and expanded our handicraft department. Notably, Sheela Pagare, a talented seamstress trained at our centre, has now returned as an instructor, sharing her skills with others in the community. We are also grateful for the dedication of our volunteers, Smruti Narvekar and Seema Thakur, who efficiently manage the tailoring department and ensure smooth operations.




Through diverse sales avenues such as stalls, exhibitions, and event orders, the products crafted here are reaching new markets, providing valuable income opportunities for our disabled participants.

Survey: Reaching The Unseen

There are many disabled individuals in our society who require support, and with the right assistance, they can lead independent and dignified lives. To reach these individuals, we conduct surveys in various neighborhoods, allowing us to identify and assist those in need. Our dedicated team of young volunteers visits nearby communities, spreading awareness about the Snehajyot organization and the services we offer.

Through these outreach efforts, many disabled individuals have been connected with our organization, and their rehabilitation process is now underway.



English Language Course

Recognizing the growing importance of the English language in today's job market and business world, Snehajyot has initiated English language classes for our disabled friends, understanding that proficiency in English can significantly enhance their personal and professional lives. These classes are conducted by Mr. Suresh Bhatia, the Head of the Video Department at Paani Foundation, who generously volunteers his time, leading sessions at our organization two Sundays each month.



Our first batch of six students is set to complete the course soon. The classes have been meticulously organized and managed by our dedicated volunteer, Ujjwala Kadam. We are deeply satisfied with the remarkable progress shown by the students in their English language skills, which reflects the effectiveness of this initiative.

Steps of Hope: Krisha's Inspiring Progress







In our previous report, we shared the story of our young warrior, Krisha. Once unable to sit up on her own, Krisha has now made remarkable progress in walking. This incredible transformation has been made possible through the dedicated efforts of our volunteer, Swati Bhave, who provided consistent support for Krisha's physiotherapy.

Additionally, the persistent follow-up by our volunteer, Padmaja Vaidya Tai has played a crucial role in this journey. Krisha received appropriate treatment through Snehajyot at very early stage, resulting in significant improvement in her physical and mental condition. Snehajyot wishes to reach many more children with similar needs in the future and aims to establish cost-effective treatment centres that provide excellent physiotherapy.

Kiran and Tanuj Ramoshi

A brother and sister duo, live in Nalasopara. Since childhood, they have suffered from a condition that prevents their bodies from producing calcium. This has stunted their growth, and even a small wrong move can lead to fractures. Despite these challenges, their parents raised them with courage and ensured they received an education. Today, Kiran is in the 10th grade, and Tanuj is in the 8th grade. Tanuj aspires to become a computer engineer, while Kiran is an exceptionally talented artist.

Their father, who was already managing all these responsibilities while driving a rickshaw, suffered a paralysis attack two years ago. Yet, with the support of his wife, they continued to move forward. The family lives on the third floor of a building without an elevator, in a rented room they can afford. Despite the challenges, Kiran and Tanuj's parents faithfully carry them up and down the stairs every day, ensuring they reach school.







We became acquainted with this family through our dedicated volunteer, Niranjan Jadhav. The pure-hearted parents and the sweet children, Tanuj and Kiran, won the hearts of all our volunteers at the first meeting, and it was decided that something must be done for these children. Despite their adverse circumstances, the determination of these kids to continue their education and create their own identity inspired us to help them on their journey. It was at this moment that our well-wisher, Mr. Viral Shah, stepped forward like an angel, and with his support, we were able to provide a specially designed scooter with a sidecar for this family yesterday.

With the new two-wheeler, the family no longer has to deal with these long, tiring walks. The vehicle has made it much easier and much more manageable for them to get to school and other important places. This means that children do attend school more regularly and benefit from a better education.

The vehicle has also opened up new opportunities for the family. They recently took a trip to the beach, which was something they couldn't do before. This outing has been great for the children, giving them a chance to experience something new and enjoy themselves. We are superhappy to share that Kiran has passed her SSC & entered into college recently for higher education. And Tanuj has passed 8th std exam & entered into 9th std.

Expanding UDID Card Support for 2024

Over the past year, Snehajyot has deepened its commitment to helping individuals with disabilities obtain their UDID cards. Thanks to the tireless efforts of our volunteers, Namita Tendulkar and Dr. Manjusha Shewale, we have assisted 95 individuals, enhancing our process to make it more efficient and accessible. Their dedication in managing documentation and medical check-ups has been pivotal.

We take pride in the positive impact we've made and remain dedicated to breaking down barriers and fostering inclusivity for all.





Enhanced Counseling Support: Nurturing Positivity










Championing Education: Supporting the Next Generation

I. Significant Accounting Policies

- i) The society follows "Accrual Basis" method of accounting. The incomes as well as expenses are accounted on accrual basis.
- ii) Fixed assets are stated at cost less depreciation. The cost comprises of purchase price and any attributable cost of bringing the assets to working condition for its intended use. The subsidy received for solar project has been reduced from the cost of the project.
- iii) Depreciation has been provided on written down value basis generally at the rates specified in Income Tax Act. 1961 for Furniture @ 10%, Vehicles @15%. On other assets Equipment's etc., depreciation is charged @15% pa, computers @40%, on Buildings @ 5% p.a.
- iv) Investments are stated at cost.
- Closing stock is valued at lower of cost or net realizable value.

II Notes to Accounts

- The Cash on hand Rs. 9,108/- as on 31st March'2024, was physically verified by the Management.
- ii) The Fixed Assets Furniture, Fixtures, Computers & other Equipment's stated in the Balance Sheet were in use and verified by the management.
- iii) Investment of Rs. 14,10,000 in fixed deposit for Donations of Rs. 14,10,000 received towards corpus fund during the current year is made within the end of the current financial year with Schedule Bank.
- iv) Previous year's figures have been regrouped wherever necessary.


